Executive summary:

After another very busy year for our Legal Accounts and Finance Systems division, we've seen existing talent shortage problems continue to heighten and challenge employers, with salary expectations rising in the face of competition and counter offer activity.

Ensuring staff are appropriately remunerated in line with competitors is just as important as ever, but the rapid growth in starting salaries for certain disciplines is becoming unsustainable as it inevitably raises expectations across wider finance teams. Finance Systems resources have long been stretched within the legal sector, but we're now seeing the same for developing eBilling and Pricing functions.

With only a small handful of sizeable firms actively training and developing entry level candidates across a range of finance functions, it's hard to see this issue easing for quite some time. Considering applicants from outside of the legal sector is one solution, but identifying the individuals who will transition and settle in to a law firm environment is crucial. We are now regularly meeting individuals from other industry backgrounds to assess their suitability and discuss the nuances of working within the legal sector.

Whilst we have made significant progress in placements secured at executive management level through our team, movement at senior levels in general has been sluggish over the last 12 months, with only infrequent moves at Finance Director and Financial Controller level. There is however a desire for change from a sizeable portion of individuals currently within these roles. New entrants from other industry backgrounds over recent years has cut short the merry-go-round of opportunities within the sector as seen in past years, but the thirst for change may well see an increase in activity over the year ahead.

Merger activity and the decline of KWM's European operation has seen occasional fluctuations in the availability of candidates over the past year, and it appears likely that there is still more to come. The speed in which the majority of departing employees were able to secure new employment, mostly without compromising on salary, is an encouraging sign for the health of the market however and should provide some comfort to those feeling uncertain about their job security in the face of merger talk or outsourcing.
